Agenda for MMMSL League Meeting held on January 31<sup>st</sup>, 2006

1) Old Business

- a) Update of delinquent payment from summer 2005 Flying Eagles Team- \$350 of the \$450 owed to Jerry Fulcher has been collected by Flying Eagle team members. As of Monday January 30, Oscar Castaneda, team manager had not contributed. Discussion on recommended disciplinary action for Oscar
  - i. *The league agreed to suspend Oscar Castaneda indefinitely until the unpaid balance of \$100 is paid to Jerry Fulcher. Once the balance is paid the league will consider re-instating Oscar. The league agreed to go ahead and pay Jerry Fulcher the \$100 difference owed by Oscar if he does not pay.*
- b) Update on collection of \$8 per team from summer 2005 season. Status of reimbursement to Matt Williams \$60 from 2005 and \$60 for 2006 website and reimbursement of \$37 to Jerry Fulcher for unpaid 2005 expenses.
  - i. *There is a chunk of money collected, however, at the meeting there was not a tally of which teams have paid and which teams still have a balance. Matt Williams is still owed \$60 from 2005 and \$60 from 2006 website expenses. Jerry Fulcher is still owed \$21 (\$37-\$16 (2 teams)) for unpaid 2005 expenses as well.*

- c) Under 18 players- MSA apparently does not have a policy on this. Suggest using a release form similar to the MSYSA form. MMMSL league should formally decide if this will be allowed and include decision in by-laws
  - i. *MMMSL agreed to adapt a release form for under age 18 players to be signed by parents and notarized by a notary public who wish to participate in the Men's Open Division.*

  - i. *MSA league fee will be paid from the MMMSL budget. Currently the Registrar position in the MMMSL is still open. John Wolenberg will contact CASL board for possible help. Current responsibility will be placed on the vice-president of each division.*
